About 50 folders. Appear to date from 1978 Senate floor debate on S.2467 (Labor Law Reform Act; National Labor Relations Act amendments), which eventually fails to pass Senate (other than the bill prints, there are no dates on the material). Each folder relates to an individual amendment to the committee-passed version that was likely to be proposed on the floor by Senators Helms, Hatch, Kennedy, et al. (apparently about 350 floor amendments were offered.) Typically, the outside of each folder has a brief note with HAW talking points. Inside each typical folder is the print of the amendment, section of the bill subject to the amendment, and a pocket folder containing HAW's floor remarks. Some folders contain some additional information, including what appear to be drafts of remarks.
